## **Decision NO. (945)**

In accordance with (a) item of the forty-second of the temporary edicts. Revolution Command Council decided through its held edict in 15/8/1976 the follows:

1. The item (2) of revolution command council (226) in 22/8/1976 the follows:

a. Demeanor papers are not permitted to be used just when fulfilling building the house and must had a determined time of no less than ten years from completing building the house.

b.There is a necessary to provide Tameem Governorate and at the same time to except the procedures of transferring or renting in Mortgage Bank, the justice manager are prevented from confirming upon any contract or agreement that related by property or the built house. Even to arrange any right of both of them. Any contract or agreement which may contrast these orders will be considered to be invalid and must not be depended upon.
